<p>Drug Death Review</p>	<ul style="list-style-type: none"> No update official update until after the next meeting on March 9th. There are 15 cases on the agenda. 69 cases confirmed 5 cases pending Dr. Marsh shared that Fentanyl is being pressed into tablets which look like oxycodone, but are 50 to 100 times more potent. Fentanyl is a "better high", but much more dangerous. Last weekend saw 4 drug related deaths 36% of cases are drug deaths
